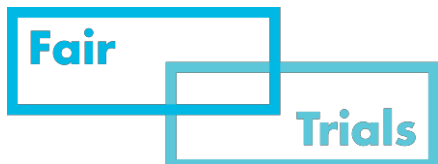


### Legal Experts Advisory Panel Organizations as at 30 May 2017
